

## Data privacy information WAM

The companies of Deutsche Telekom IT Solutions attach great importance to protecting your personal data. We always inform you what personal data we collect, how your data is used, and how you can influence the process.

### 1. What data is recorded, how is it used, and how long is it stored in WAM?

Logging in: if you want to use the app, you have to login with your company account number which is linked with your corporate e-mail address and organizational unit (Art. 6 (1) a GDPR).

In order to provide you the latest news, your reading activity regarding the articles in the app will be recorded (Art. 6 (1) a GDPR). This way the app can show you the latest news and articles.

The data will be deleted after 1 month you leave the company.

### 2. Authorizations

For the app to work on your device, it needs access to various functions and data on the device. You need to grant certain authorizations to do so (Art. 6 (1) a GDPR).

The authorizations are programmed differently by the various manufacturers. Individual authorizations may e.g. be combined in authorization categories, and you can only grant consent to the authorization category as a whole.

Please remember that if you withhold consent for one or a number of authorizations, you may not have access to the full range of functions offered by our app. If you have granted authorizations, we will only use them to the extent described below:

Internet communication: the app requires access to the Internet via Wi-Fi or mobile data network for the purpose of downloading content.

The app also shows the SPOC's of the company as contact points to different departments. In this regard the following employee data is displayed: name, company e-mail address and phone number, according to the legitimate interest of the controllers (Art. 6. (1) f) GDPR).

### 3. Does the app send push notifications?

Push notifications are messages that the app sends to your device and that are displayed with top priority. This app uses push notifications by default, provided you have given your consent during the app installation or the first time you use the app (Art. 6 (1) a GDPR).

You can deactivate receipt of push notifications at any time in your device settings.

### 4. Who is responsible for data processing? Who should I contact if I have any queries regarding data privacy at Deutsche Telekom IT Solutions?

Deutsche Telekom ITTC Hungary Ltd. and Deutsche Telekom TSI Hungary Ltd. (both seated at 1097 Budapest, Konyves Kalman krt. 36.) are acting as joint data controllers.

#### 5. What rights do I have?

You have the right

- a) To request information on the categories of personal data concerned, the purposes of the processing, any recipients of the data, and the envisaged storage period (Art. 15 GDPR);
- b) To request that incorrect or incomplete data be rectified or supplemented (Article 16 GDPR);
- c) To withdraw consent at any time with effect for the future (Art. 7 (3) GDPR);
- d) To object to the processing of data on the grounds of legitimate interests, for reasons relating to your particular situation (Article 21 (1) GDPR);
- e) To request the erasure of data in certain cases under Art. 17 GDPR – especially if the data is no longer necessary in relation to the purposes for which it was collected or is unlawfully processed, or you withdraw your consent according to (c) above or object according to (d) above;
- f) To demand, under certain circumstances, the restriction of data where erasure is not possible or the erasure obligation is disputed (Art. 18 GDPR);
- g) To data portability, i.e., you can receive the data that you provided to us in a commonly used and machine-readable format such as CSV, and can, where necessary, transfer the data to others (Art. 20 GDPR);
- h) To file a complaint with the competent supervisory authority (Nemzeti Adatvédelmi és Információs Zsolt Hatosag, phone: +3613911400, mailing address: 1363 Budapest, Pf.: 9, [ugyfelszolgalat@naih.hu](mailto:ugyfelszolgalat@naih.hu)).

#### 6. Where is my data processed?

Your data will only be stored locally in the app and on DT-ITS company servers and in Europe.

#### 7. Consent to the processing of your personal data

By clicking the checkbox, you declare that you have read the privacy policy and agree to the processing of your data in WAM. Your declaration will be stored. You can request the deletion of your data at any time.

If you do not consent to the above-mentioned terms, you will not be able to use the features of WAM and will not receive any news and other company information from us via this app.
